## **CONCERT NOTES**

## **42<sup>nd</sup> Season Begins with Music Inspired by Stories and Art from the Homelands**

Monday, September 30, 2024 – 7:30 pm Brunswick High School Auditorium



The concert opens with a rollicking overture from Russian composer, **Mikhail Glinka's** opera *Ruslan and Ludmila*. The opera is based on a narrative poem by Alexander Pushkin,

considered Russia's greatest poet. The music is enhanced by an Eastern flavor borrowing from Russian folk material, with an allusion to European dance music, and a decided advanced treatment of harmony. All of this is apparent in the overture which is considered a workout for violinists and a nightmare for bassoonists.



A celebration of the African spirit follows with American composer **Brian Raphael Nabors'** Of Earth and Sky: Tales from the Motherland. Nabors music draws from a combination of classical, Jazz Funk, R&B and Gospel with the modern flair of contemporary classical music, using Gospel as the underlying force. Tales

draws on his special interest in creating a symphonic tapestry of music based on stories from Africa and the Caribbean by weaving three distinct African legends together and culminating in a celebratory finale.

The Opening Night program closes with Russian composer **Modest Mussorgsky's** *Pictures at an* 

Exhibition. The music takes the listener through an exhibition of paintings by artist Victor Hartman who was a close friend of the composer.



Originally written as a piano suite, its symphonic possibilities soon became evident. Over 20 adaptations have been created, and French composer **Maurice Ravel's** version has become

the most recorded and performed. faithful scoring, Ravel amplifies both the wit and feeling of the piano piece and uses the entire orchestra to create musical characters from the paintings. The music is times lyrical, sprightly, folksy, eerie, and majestic. Listen for the Promenade theme



throughout that indicates a visitor strolling through the exhibit.



# Coastal Symphony of Georgia Participates in Causeway Celebration

The F.J. TORRAS CAUSEWAY CENTENNIAL CELEBRATION was a public event to celebrate 100 years since the opening of the FJ Torras Causeway that connected St Simons and Sea Island to Brunswick.

**Les Roettges**, the Principal Flute of the Coastal Symphony who holds *The Ruth Heagy Principal Flute Chair*, opened the Causeway Celebration Pageant on July 13, 2024 in Gascoigne Park with a special flute solo written by Sidney Lanier. The Coastal Symphony was honored to participate in and be a sponsor of this historic event.

## **CSG Executive Director Leadership Transition**



Sharon Flores, the longstanding Executive Director of the Coastal Symphony of Georgia, is set to retire after an impactful eight-year tenure in this role.

Having joined the Coastal Symphony Board in 2006, she served as President from 2014 to 2016. Under her leadership, the organization experienced

significant growth, including the transition to a fully professional orchestra, the relocation to the new Brunswick High School Auditorium in 2016, and the recruitment of a full-time General Manager along with two distinguished Music Directors and Conductors—Maestro Luis Haza and the current Conductor, Michelle Merrill.

Sharon expressed her ongoing passion for the Coastal Symphony and conveyed her gratitude for the lasting friendships she has cultivated with board members, musicians, and symphony patrons over the past 18 years.

Lauren Kase is thrilled to join the Coastal Symphony of Georgia as its Executive Director. Previously, Lauren directed development for The University of Virginia's Frank Batten School of Leadership and Public Policy, Duke University's Sanford School of Public Policy,



and New York University's Silver School of Social Work, but perhaps her favorite role was managing The Juilliard School's Second Century Fund. Lauren grew up studying classical voice and feels it is a true privilege to support Music Director Michelle Merrill, the musicians of the Coastal Symphony, and the community they inspire. Lauren received a B.A. in Public Policy from Duke University and a Master of Social Work from the University of Pennsylvania. She and her husband Keeva Kase live with their children Ketch and Claire on St. Simons Island.

## Musical Mentors

Bringing Professional Musicians to School Students - 8th Annual Program to Begin this School Year

One of the Coastal Symphony of Georgia's most successful signature events has been the Musical Mentors Program – now beginning its eighth season of taking professional musicians into area schools. Last year, a new partnership with the Golden Isles Youth Orchestra greatly expanded the project with the two organizations combining forces in the Strings-On school initiative. The program's outreach and impact increased in the 2023-24 school year from one to two mentors visiting schools per year, to ten mentors interacting with youngsters eager to meet them. "We also moved from visiting one to four classrooms per year to more than 50 and from under 100 children impacted to almost 1,000," says CSG board president Leslie Graitcer.

The Strings-On Program, a one week per school initiative, provides every fifth grader with a violin and instruction designed to whet appetites and encourage music participation in middle and high school. GIYO instructors work with the students for four days, teaching them a piece to play with a CSG Musical Mentor who arrives at the end of the week. The mentor has had a big build-up all week achieving near Super Star status by the time he or she arrives to hear the students play their song and then play with them. The mentor answers questions about life as a professional musician, and often plays an instrument other than a violin allowing the youngsters to learn about other instruments as well. The feedback from CSG musicians reflects how much they enjoy the process: "I had a lovely time when I was there and would be happy to join again next season!" "Being able to perform for students and see them smile was

so rewarding." "As for continuing, YES, YES, YES!" And that is exactly what Graitcer and her team who shepherd this program

intends to do in the coming school year. "We are so grateful this program has caught on like wildfire," she says, "and we look forward to bringing music education to even more children in the coming season."
